#### **MODULE 1: POLITICS**

#### 1. Week: Fundamentals of EU Politics (İ. EFE) – 18.09.2024

# 4. Week: The EU's Supranational Structure: Institutions and Decision-Making Process (Y. AVAR) – 9.10.2024

# 10. Week: EU law and refugee rights (S. ŘEZNÍKOVÁ) – 20.11.2024

Scope: This session introduces the EU framework facilitating refugee rights, with a specific focus on Common European Asylum System within the context of European and international human rights law. The emphasis is put on current contested issues as revealed through case law of the Court of Justice of the European Union.

#### Learning Outcomes: By the end of the session, students should be able to:

- 1. To understand the roles of major EU institutions in facilitating refugee rights and safeguarding equality among refugees of various origins and be familiar with the most important sources of law
- To critically assess the shortcomings of the current EU's legal framework as revealed through case law, especially inequalities of treatment in different EU Member States and among refugees of different ethnic origins, languages, and religions
- 3. To propose legislative amendments aiming at greater equality and predictability of the pertaining legal measures

# 13. Week: Religion and Secularism in the EU (O. ÜLKER) – 11.12.2024

**Scope:** This unit examines how religious beliefs, practices and institutions intersect with political processes and structures in the diverse and evolving environment of the European Union through legal frameworks, policy issues and the field of secularism and pluralism

#### **Learning Outcomes:**

- 1. Evaluate the legal frameworks and policies governing religious diversity within the EU and its member states.
- 2. Assess the impact of religious identities on political decision-making processes and the formation of European identities
- 3. Understand the challenges and opportunities posed by religious diversity for the EU's commitment to values such as tolerance, human rights, and pluralism.

# 15. Week: Artistic Expression of Otherness (O. ÜLKER) – 25.12.2024

The unit will start with screening a documentary "The Migration of Art", a project coordinated by the instructor, which focuses on refugee artists living in Turkey. Later the documentary will be analysed in terms of the relationship between migration and art in a conference hall

# Learning Outcomes:

- 1. Develop a critical understanding of the challenges faced by refugee artists and the role of art in expressing their unique experiences of otherness and displacement.
- 2. Explore the intersectionality of identity as artists and migrants, examining how these dual roles influence their artistic expression and sense of belonging.
- 3. To examine how art serves as a tool for cultural adaptation and integration, particularly for refugees, fostering understanding and empathy within the broader society.
